Dear Friend of New York City Scouting and Exploring,

Thanks to your generous involvement, we have much to point to with pride as we reflect on this past year.

With the launch of Scouts BSA, older girls have joined Scouting and are working toward being the first class of female Eagle Scouts. Our volunteers have developed 14 new female Scouts BSA Troops, with more in formation. One new female unit, Troop 253, won Troop of the Week at Camp Keowa in Ten Mile River! And close to 3,500 girls have joined Cub Scouts, the highest number of any Council in the Northeast.

Advancement activities are a key focus for any Scout, encouraging young people to explore a variety of subjects in depth. We are pleased to report that our Scouts earned over 3,600 Merit Badges in Science, Technology, Engineering, and Math, and 176 young people earned the highest rank of Eagle Scout.

With over 8,600 Scouts attending summer camp and 75,000 youth and adults visiting camp on weekends, there were lots of opportunities to earn advancement in the outdoors.

We served a record number of young men and women in our career preparedness Exploring Law Enforcement Academy, with 349 Explorers graduating. New research studies on Exploring show a strong link between participation and enhanced academic performance and career prospects.

In all, over 20,000 New York City boys and girls learned skills that help prepare them for success in life through our Scouting and Exploring programs. Amidst the serious challenges facing the National Boy Scouts of America, the Greater New York Councils remains committed to providing a safe, structured learning environment for New York City youth. We couldn't do any of this without the continued dedication and support of our volunteers, staff, and supporters.





# Scouts BSA's Inaugural Year

The welcoming of girls into Scouts BSA was incredibly smooth, and girls began joining on February 1, 2019. We now have 14 Scouts BSA female Troops, most of which were linked to a male Troop. We started our first Scouts BSA male Troop because of a linked Scouts BSA female troop this fall in Manhattan. A number of our first female Troops went to camp, and Troop 253 won Troop of the Week at Camp Keowa!

And we now have over, 3,400 girls engaged in Cub Scout Dens. We launched our first female Cub Scout Pack on Staten Island which is linked to a Scouts BSA female Troop.

# **Times Square Pinewood Derby**



# **Career-Based Explorers Learn Marketing**

9th Decimal hosted our Explorers for a "Shark Tank" challenge (inspired by the television series), where the students worked in teams to develop a pitch for products and present to the professionals. It was a great way for young people to experience firsthand what it is like to promote a business idea.

# Scoutreach

We had our annual Winter Wonderland event, where brothers from La Unidad Latina, Lamba Upsilon Lambda Fraternity Incorporated and Explorers helped lead the activities. Making Stockings and ornaments and hosting a magic show and dance performance.



# Law Enforcement Exploring

This summer a record 349 Explorers graduated from the Law Enforcement Academy, a great milestone in its 25th year. Explorers spent two weeks at Fordham University for drills and classroom instruction and then headed to Camp Keowa at Ten Mile River for scenario training, first aid, rappelling, swimming, and outdoor adventure. Over 70 law enforcement officers served as mentors and instructors for the Academy, representing the FBI, DEA, NYPD, and many more agencies.

Our first annual Fall Invitational Conference, where the highest-performing Explorers in Law Enforcement are invited to compete at Alpine Scout Camp for top honors. Held on November 11, It was a great success!

Shooting for the Stars: on July 8th, NYPD Explorers enjoyed a live video chat with astronauts Christina Koch and Nick Hogue, who broadcasted from the International Space Station. Explorers posed questions about life in space and the potential for life on Mars. Explorers also asked what it takes to become an astronaut. Brianna, interviewed by CBS, said that "it was inspiring to all us young people, because it showed that persistence and hard work is key."

# **Youth Protection Symposium**

We hosted our first annual Youth Protection Symposium on November 12th, at the Interchurch Center. We were joined by Scouters and youth development professionals from New York and surrounding areas to hear from experts in the field how we protect youth in our care. Our keynote speaker was Michael Johnson, National Director of Youth Protection Programs for the national Scout organization. We also welcomed speakers from the FBI and Homeland Security Investigations, among others, who shared the latest developments on this important topic.


# **Survey Results**

The following are the Scout Leader Camping Survey results on the impact of summer camp last year. A high percentage of leaders reported improvements for their Scout participants in:

- · Resilience (90%)
- · Leadership (90%)
- Teamwork (92%)
- · Caring for others (84%)
- Communication (83%)
- Responsibility (92%)
- Self-esteem (90%)

And an overwhelming 97% agreed that summer camp rank advancement activities help prepare Scouts for the school year ahead.

As you can see, outdoor adventure and education can make a significant difference in a child's life.



# William H. Pouch Scout Camp

As we continue to expand our year-round programming at Pouch, we welcomed a number of city schools who came for a day of outdoor education. Schools created their own curriculum based on what they are currently working on in the classroom and then took it outside to expand on the lesson. John Lavelle Prep School, for example, was studying the Renaissance period. We established several stations around camp focusing on art, weaponry, and cuisine of the time period. Central and Canarsie Ascend Schools visited camp for an "Outdoor Learning Adventure" for students who have never had the chance to visit camp before. Climbing, archery, hiking, and C.O.P.E. activities were all part of their day.

Over 5,000 Staten Island school children participated in this new program in its first year!

We introduced Family Camping, where Scouts can camp with their families for two or more nights, so long as one adult is a BSA member. We know that Scouting brings families together, and this is especially true while sharing adventures in the great outdoors!

Most New York City kids never have the chance to go to camp. Rank advancement activities in summer camp develop fortitude and prepare Scouts for school success.

For one Scout in particular, it was his first time being away from home for more than a day and his first time outside of Brooklyn. As his mother explained, "attending summer camp helped to show him that there is much more out there and that he can do many things on his own."

# **Family Camping**

With an enhanced focus on Family Scouting this year, we now offer camping opportunities to our Scouting families, whether in a tent or a cabin. They do not have to attend with a unit. Families spending time together is an important part of Scouting so we are pleased to offer this new way to go camping.




