

PROGRAM HIGHLIGHTS

We offer programs for boys and girls ages 6-20 throughout the five boroughs: Cub Scouts, Boy Scouts, Scoutreach, Exploring, Learning for Life, and Venturing

> **Fishing Derby Prospect Park:** Held in Brooklyn's Prospect Park on June 20th, this Hooked on Scouting free event welcomed over 250 boys and girls, all of whom got a new Zebco fishing rod and reel to use and take home. After their lesson from pro fisherman Tom Redington, kids raced off to the lake to try to catch the biggest fish of the day. After all the fish caught were weighed they were released back into the lake. In addition to the fishing,

Zebco brought a fishing simulator

ride game, which was a huge hit. Fishing League Worldwide pros and other experts provided instruction for this inaugural event. Derby winner Amaya Edmond (see photo) had never fished before, but she is looking forward to building on what she learned: "it was cool."



Times Square Pinewood Derby: More than 2,000 Scouts and Scouters from 60 councils across the country joined us at Times Square to race their cars on June 24th at the Marriott Marquis in Manhattan.

More than just an opportunity to show off their skills, the Derby is a great chance for Scouts and adults to work together on a common goal while having fun. In addition to racing their own pinewood derby cars, Scouts built LEGO cars at the event and raced them down an exhibition track. We gave out 52 winning trophies, but all participants had the experience of a lifetime at this "Crossroads of the World" event.







Scouts and Explorers Study Architecture from the Top of New York City: On May 27, Scouts from the city and the tri-state area visited One World Trade Center (also known as the "Freedom Tower") to earn their Architecture Merit Badge as part of our Merit Badge Pro Series. Scouts learn from industry experts at unique venues and worksites, for unforgettable experiences. Scouts went to the very top of the building, the 104th floor, and learned about sustainable structures and buildings.

Also in May, a new Exploring post hosted by the Port Authority of New York and New Jersey visited One World Trade Center, with a tour of the Oculus, the memorial pools, and the Observation Deck. They learned about the structure of the Oculus, and how it expands and contracts

depending on wind speed and temperature.

Hero Explorer: The NYPD honored 17 year-old Staten Island Explorer Eric Roman with a certificate of appreciation after he helped rescue an elderly woman who he found on the highway. She seemed disoriented and in distress. Eric pulled over and helped get her an ambulance, and met her at the hospital to make sure she was going to be OK. 87 year-old Laura Farr had gotten lost trying to visit her grandchildren. Farr was very happy to be rescued, and said Roman has promised to continue to watch out for her safety. Eric wants to be a police officer when he grows up. Chief Edward Delatorre of the 122nd Precinct explained of Eric, "he's just a really good example of what the future of this city has in store for it." Eric was featured on CBS News.



Scoutreach Takes a Hike:

Over 200 Cub Scouts in our after-school Scoutreach program visited Van Cortlandt Park in November for this annual daylong event. In addition to a nature hike in this beautiful Bronx park, Scouts enjoy lots of fun, games, and Scouting activities. Outdoor adventure is a fun way for Cub Scouts in New York City to learn about the natural world around us. During the spring and summer, hundreds of Scoutreach participants joined us at Alpine Scout Camp in New Jersey for weekend, spring, and residential summer camp.



Exploration Merit Badge: On November 4th, 76 NYC Boy Scouts received mentoring and counseling in the new BSA Exploration Merit Badge at the iconic Explorers Club. Many thanks to the club for hosting our Scouts. Special guest presenters included neurosurgeon Dr. Ken Kamler, caver Peter Lenahan, and Emmy-winning filmmaker Aleks Rikhterman.

Ten Mile River 90th Anniversary: August 4-6 over 800 friends and alumni came to Ten Mile **River Scout Reservation** (TMR) to reconnect and celebrate 90 years of preparing young men and women for life at this iconic camp. Franklin Delano Roosevelt led the effort to fund, acquire, and develop TMR as President of the New York City Boy Scout Foundation. TMR is one of the largest council-owned scout camps in the world and has hosted over

one million scouts. Activities

included a moving opening ceremony, swimming, scout skills, and a rededication of Camp Keowa's dining hall. Special thanks to Tom and Patricia Bain for underwriting the very significant renovation of this dining hall.

Distinguished guests joined us, including Distinguished Eagle Scout Rafael "Ray" Suarez, Jr., a prominent broadcast journalist, and legendary musician Tito Puente, Jr. Mr. Suarez gave a stirring speech on how Scouting helped him, while growing up in Brooklyn, become the person that he is, and how it changes lives today. He said The Scout Law "is a code, a set of goals, now needed more than ever than at any time over the last 90 years."

William H. Pouch Scout Camp: The William H. Pouch Scout Camp saw some physical improvements that will go a long way, including updating the Stewart comfort station and placing a water line all the way back to the amphitheater for campfires at district and council events. The Pouch Day Camp saw an awesome refresh of its program, incorporating theme days and competitions each week, as well as two stargazing events. Be sure to visit the Berlin Lodge and Maple Cabin after they receive improvements in 2018. Special thanks to the dedicated volunteer corps that spends many Wednesdays at Pouch making improvements.

Improvements for the Next Century of Scouting at Ten Mile River: As we welcome more families as a whole to camp together, it is important that we continue to make our facilities as accessible as possible.

Special thanks to those friends of Scouting who helped us make important investments in TMR's facilities. We made major improvements to the Camp Keowa dining hall including new flooring, windows and walls, and an outdoor deck/teaching area. We created a new amphitheater campfire ring at Camp Ranachqua. Throughout the property we added and expanded high speed internet service so leaders can stay in touch with home and office while they are at camp.



"Scouting brings children and teens from all different backgrounds together to do something positive. With my Pack, we did Scouts in the Park which is when we helped clean up areas in the Rockaways after Hurricane Sandy, helped feed the animals at the Queens Zoo, and cleaned up Kissena Park. 
