Dear Friend of New York City Scouting and Exploring,

The first point of the Scout Law is that a Scout is Trustworthy – we encourage our young people to see the truth, to be open-minded and to evaluate new ideas or changes on merit. Scouting is now making some exciting changes to its time-tested programs that will make us stronger and better serve our communities.

This has been a remarkable year of transformation and growth. We are pleased to report we have opened a new program at a transitional family homeless shelter for boys and girls. We have welcomed hundreds of new Law Enforcement Explorers this year and opened many new posts that students can choose from to explore a variety of careers. We've seen growth in membership in a number of Scouting districts.

We welcomed girls for the first time in Cub Scouts, and in 2019 older girls will have the opportunity to earn the rank of Eagle Scout. Citywide we have 2,087 girls so far and nationally the number of enrolled girls exceeds 78,000.

Our commitment to outdoor education remains strong, serving tens of thousands of families, Scouts, and Explorers throughout the year, at William H. Pouch Scout Camp, Alpine Scout Camp and Ten Mile River Scout Reservation.

We are very pleased to report that we have moved our Scout Service Center to 475 Riverside Drive, near Columbia University. We look forward to creating partnerships in the neighborhood to benefit local youth.

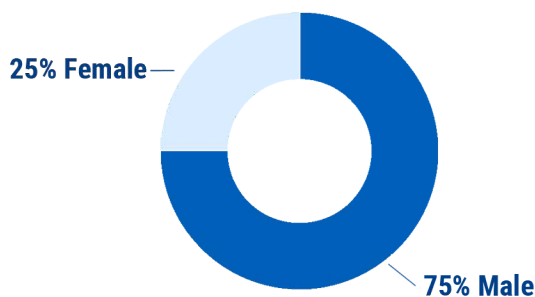

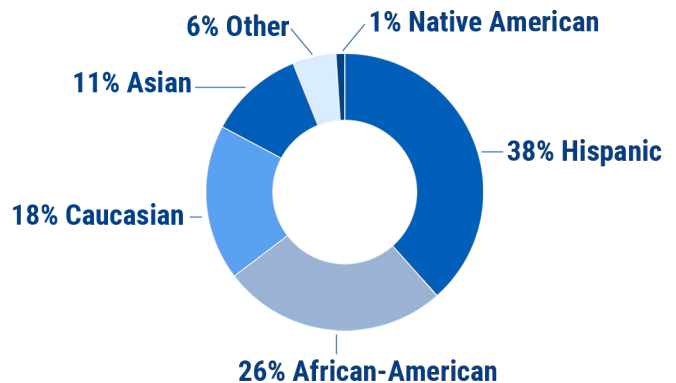

Program Highlights

Launch of Family Scouting Program

Beginning in the spring of 2018, eager New York City Packs became early adopters of Family Scouting, and welcomed girls to join Cub Scouts. John E. Reeves Cub World celebrated their first summer with female Cub Scouts and their families. The program officially kicked off city-wide in September with family scouting packs in all five boroughs. Sanjay Shirke, whose son and daughter are both in Pack 111, explained it has strengthened the family to participate in Scouting together. *"There's a sister who now happily joins us on campouts. Her mom does too, and brings their toddler son along. The most rewarding aspect has been to watch as girls and their families begin to grow through Scouting, in exactly the same way that boys have."*



Merit Badge Pro-Series

Large and small local businesses and international corporations host Scouts for full day seminars that provide Scouts a glimpse at a profession and provide leadership to complete merit badge requirements. Fun events held this year include our first Welding Merit Badge workshop, hosted by Metal Workshop Fantasy in Brooklyn. Students also earned credit toward their Architecture Merit Badge at One World Trade Center.



Business Exploring

WSP engineer advisors started out giving an overview of careers in engineering and other types of projects that the company manages. Explorers at WSP then learned how bridges are constructed and built their own mini-bridges. Putting their new creations to a stress test helped them see what techniques were most successful. It is these type of hands-on learning experiences that helps student Explorers learn what kind of careers they want to pursue after high school.



As Dylan D., an Explorer explained, *"I am so lucky to have the Exploring Program in my life; it has been a great opportunity to learn about different industries and careers. I learned a lot of new things, made new friends, and forged many new professional contacts."*



Law Enforcement Exploring

The NYPD presented its first Lesandro “Junior” Guzman-Feliz college scholarships to two Law Enforcement Academy graduates this summer, Nelson Malachi and Naomi Zambrano. They each received \$5,000 toward tuition and college expenses. This scholarship program honors the memory of Junior, an NYPD Explorer and aspiring police officer, who was tragically killed in June. His story raised awareness of the dangers of gang violence that many of our young people face, and inspired hundreds of New York City young men and women to join the Exploring program.



Times Square Pinewood Derby

On June 30th, The Greater New York Councils held the 4th Annual World Championship Pinewood Derby in Times Square, at the Marriott Marquis. We welcomed 1,500 people, including 346 Champion Racers from 21 states nationwide.



Scoutreach Homeless Pilot Project

We are pleased that our Scoutreach pilot program at the Ruth Fernandez Transitional Family Residence in the Bronx is thriving. They meet weekly and participated in our Take-A-Hike event in Van Cortlandt Park for a nature trek, learned how to use a compass, and played games.

Camping Highlights

Ten Mile River

Close to 70 Scouts from seven Troops trekked 10 miles along TMR's roads and trails at the Bronx District Trek-O-Ree in October. It was the first Trek-O-Ree at TMR, and Scouts braved the cold and rain while earning their hiking requirement for the Ten Mile River Historical Trails award. One participating Troop has several Scouts who are on the autism spectrum, including one inspiring Scout who has 70 merit badges already, and looks forward to earning his Eagle Scout rank soon. Another Scout, Carlos M., recalled, *"I enjoyed myself at the Trek-O-Ree. I was able to practice using my compass and reading the map. While on the hike it would be a little challenging because if you don't read the map correctly, you could end up taking a longer hike. At the end of the hike I received a beautiful medal. After the hike you could also go to the museum and do the activities and get a patch. Overall, I would highly recommend for every Troop to join us next time. You won't regret it!"*

Special thanks to those who helped us make important capital investments in Ten Mile River. We are grateful to volunteer Dave Malatzky, who is underwriting improvements to the Red Dot Trail, which will include installing a potable water source and refurbishing lean-tos and trail sites.

We look forward to celebrating the 90th Anniversary of Camp Ranachqua on Lake Nianque on August 3rd, when we will dedicate our newly renovated Lake Nianque Dining Hall. This extensive refurbishment includes a new roof, new layout, and expanded dining service and programmatic capacity, equipping a modernized Camp Ranachqua to better serve the next generation of Scouts.

We are deeply appreciative of the generosity of Eagle Scout Bob Natt for underwriting this critical work. Bob was a Cub Scout, Boy Scout and Explorer in Pack, Troop and Post 107 in Far Rockaway, Queens. Bob camped at Camp Nianque from 1960-1963 and was a CIT at TMR for the summer of 1964. In 1963 he earned his Eagle Scout and hiked a trek at Philmont Scout Ranch. Bob was inducted into the Order of the Arrow in 1964. In addition to serving on the Board of Directors of the Greater New York Councils, Bob is currently serving as the Den Leader of his grandson's Cub Scout Tiger Den in Connecticut.

Bob shared, *"I appreciate the opportunity to help the Greater New York Councils, and TMR specifically, which has been so important to shaping me during my teenage years. I fondly remember completing my Mile Swim on Lake Nianque, hiking the Red Dot Trail, canoeing down the Delaware all these years later. It is thrilling to return to Lake Nianque, seeing firsthand today's Scouts enjoying the very same lake and activities. It is indeed timeless."*





Alpine Scout Camp

Alpine hosted many great events this year, such as Family Fun weekends and Climb the Night Away evenings. Alpine also hosted a number of new Cub Scouts. Amaya, a female Cub Scout from Brooklyn's Pack 16, describes her first summer camp experience as a Scout:

"This past summer I attended Alpine Scout Camp as a first-year Webelos. I had never attended camp as a Scout before, but I was able to receive a campership from the Brooklyn Council which made it all possible. When I realized I was the only girl as a Cub Scout, I knew I had a lot to prove. But the staff treated me just like every other Scout, and the other Scouts treated me like I was one of them. I was able to climb walls, shoot BB guns and arrows, take a hike in the woods and many more activities that are only available at camp. I left with so many new friends, and I can't wait to go camping next summer."

William H. Pouch Scout Camp

We welcomed Elise Rooker as Director of William H. Pouch Scout Camp in 2018; she is looking forward to expanding programs for Staten Island families. *"With the help of the Scouting community, Staten Island volunteers, and our staff members we hope to bring year-round opportunities for Scouts and community members during weekend program and beyond that would include outdoor activities, merit badge and social programs, as well as the expansion of our summer program during day camp."*

Some highlights this year include a new Saturday Weekend Program open to all Scouts and community members, including boating, fishing, archery, climbing, and C.O.P.E. activities.

Family Camping

With an enhanced focus on Family Scouting this year, we now offer camping opportunities to our Scouting families, whether in a tent or a cabin. They do not have to attend with a unit. Families spending time together is an important part of Scouting so we are pleased to offer this new way to go camping.

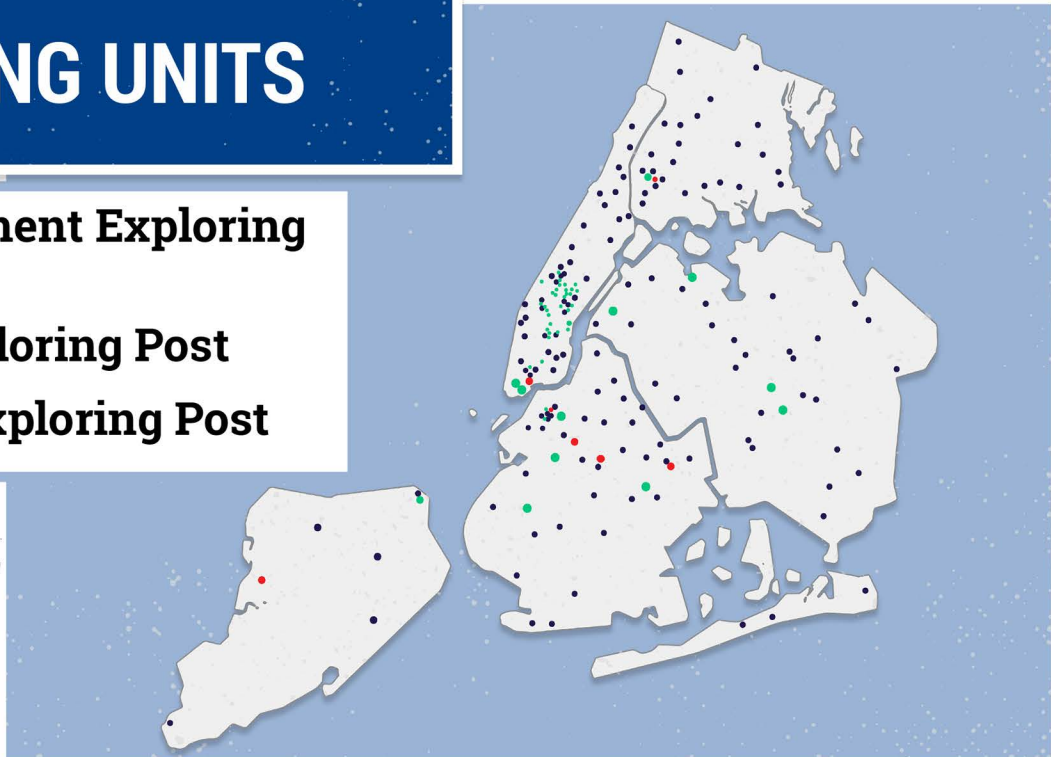

In Fond Remembrance



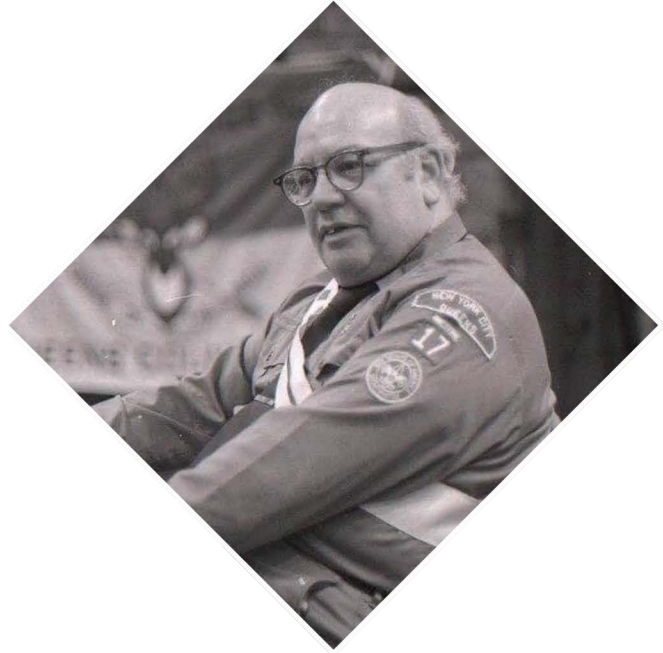
Thomas J. Moran

October 14, 1952 – August 12, 2018

It is with a heavy heart that we mourn the loss of our former long-term GNYC Board Member Thomas J. Moran. Tom was a devoted Scouter who supported the Council in many meaningful ways.

Tom worked for Mutual of America for over 43 years and the last 21 years as its Chairman, President, and CEO. He was instrumental in the company's growth into a Mutual Life Insurance Company with more than \$20 billion in assets. He will be remembered for his steadfast commitment to helping others, remarkable talent, and engaging personality.

In addition to the Boy Scouts, Tom was involved with many charitable endeavors including serving as Chairman of Concern Worldwide, and serving on the boards of The Alfred E. 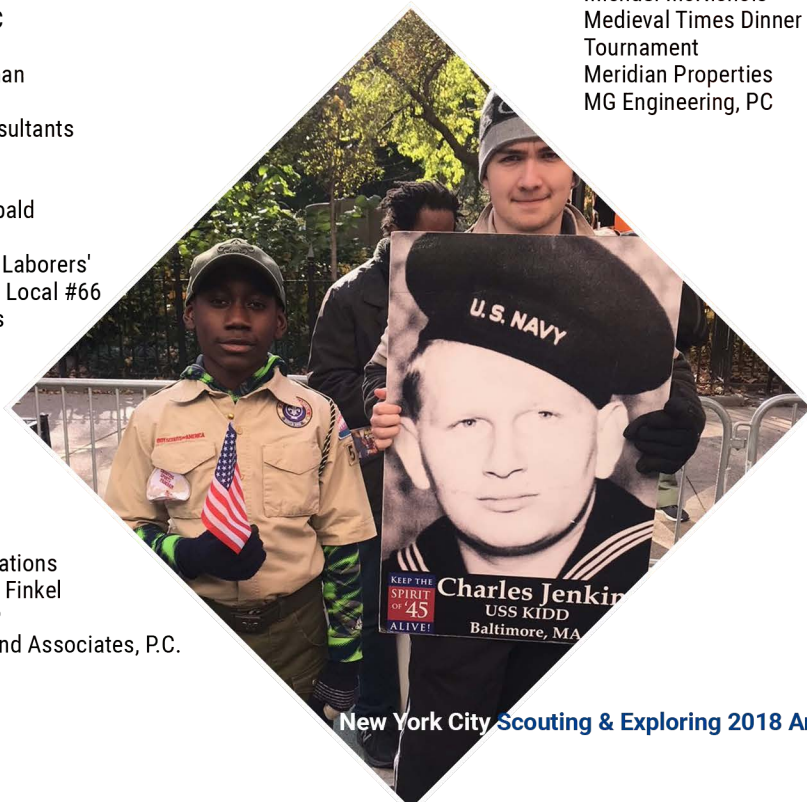
